BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Confirmation
of Order.

1.—The Restrictive Practices (Motor Spirit) Order, 1980 (S.I. No. 10
156 of 1980), made by the Minister for Industry, Commerce and
Tourism under section 8 of the Restrictive Practices Act, 1972, is
hereby confirmed.
