AN ACT TO PROVIDE FOR AN INCREASE, IN RESPECT OF  
ONE WEEK IN THE MONTH OF DECEMBER, 1980, OF  
PENSIONS UNDER THE OLD AGE PENSIONS ACTS, 1908  
TO 1980, AND THE WIDOWS' AND ORPHANS' PENSIONS  
ACTS, 1935 TO 1980, AND PENSIONS, CERTAIN ALLOW-  
ANCES, DESERTED WIFE'S BENEFIT AND DEATH BEN-  
EFIT BY WAY OF PENSION UNDER THE SOCIAL WEL-  
FARE ACTS, 1952 TO 1980.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

1.—Where a person is or becomes entitled to payment of a pension  
under the Old Age Pensions Acts, 1908 to 1980, in respect of the week  
commencing on the 12th day of December, 1980, any amount payable  
to him by way of that pension (including any increases) for that week  
shall be increased by a sum equal to that amount.

2.—(1) Where a person is or becomes entitled to payment of a  
widow's (non-contributory) pension under the Widows' and Orphans'  
Pensions Acts, 1935 to 1980, in respect of the week commencing on  
the 12th day of December, 1980, any amount payable to her by way  
of that pension (including any increases) for that week shall be  
increased by a sum equal to that amount.

(2) Where a person is or becomes entitled to payment of orphan's  
(non-contributory) pension under the Widows' and Orphans' Pensions  
Acts, 1935 to 1980, in respect of the week commencing on the 12th  
day of December, 1980, any amount payable to him by way of that  
pension for that week shall be increased by a sum equal to that  
amount.

3.—Where a person is or becomes entitled to payment of the  
following benefit or any of the following pensions or allowances under

(a) old age (contributory) pension,

(e) deserted wife's benefit,

(f) orphan's (contributory) allowance,

(i) social assistance allowance for unmarried mothers,

(j) single woman's allowance,

in respect of the week commencing on the 12th day of December, 1980, in the case of a pension or allowance mentioned in paragraph

10 (a), (d) or (f) of this section, or in respect of the week commencing on the 11th day of December, 1980, in the case of a pension, benefit or allowance mentioned in any other paragraph of this section, any amount payable to him by way of that pension, benefit or allowance (including any increases) for the appropriate week shall be increased  
15 by a sum equal to that amount.

4.—(1) Where a person is or becomes entitled to payment of  
20 disablement pension under the Social Welfare (Occupational Injuries) Act, 1966, in respect of the week commencing on the 12th day of December, 1980, any amount payable to him by way of that pension (including any increases) for that week shall be increased by a sum  
equal to that amount.

(2) Where a person is or becomes entitled to payment of death  
25 benefit under the Social Welfare (Occupational Injuries) Act, 1966, by way of pension for a widow, widower, parent or orphan in respect of the week commencing on the 12th day of December, 1980, any amount payable to him by way of that pension (including any increases) for that week shall be increased by a sum equal to that amount.

5.—This Act may be cited as the Social Welfare (Temporary  
30 Provisions) Act, 1980.
