AN ACT TO PROVIDE FOR AN INCREASE, IN RESPECT OF ONE WEEK IN THE MONTH OF DECEMBER, 1980, OF PENSIONS UNDER THE OLD AGE PENSIONS ACTS, 1908 TO 1980, AND THE WIDOWS' AND ORPHANS' PENSIONS ACTS, 1935 TO 1980, AND PENSIONS, CERTAIN ALLOW-ANCES, DESERTED WIFE'S BENEFIT AND DEATH BEN-EFIT BY WAY OF PENSION UNDER THE SOCIAL WEL-FARE ACTS, 1952 TO 1980.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Increase of pensions under Old Age Pensions Acts, 1908 to 1980, for week commencing 12th December, 1980.

Increase of pensions under Widows' and Orphans' Pensions Acts, 1935 to 1980, for week commencing 12th December. 1980

1.—Where a person is or becomes entitled to payment of a pension 15 under the Old Age Pensions Acts, 1908 to 1980, in respect of the week commencing on the 12th day of December, 1980, any amount payable to him by way of that pension (including any increases) for that week shall be increased by a sum equal to that amount.

2.—(1) Where a person is or becomes entitled to payment of a widow's (non-contributory) pension under the Widows' and Orphans' Pensions Acts, 1935 to 1980, in respect of the week commencing on the 12th day of December, 1980, any amount payable to her by way of that pension (including any increases) for that week shall be increased by a sum equal to that amount.

(2) Where a person is or becomes entitled to payment of orphan's (non-contributory) pension under the Widows' and Orphans' Pensions Acts, 1935 to 1980, in respect of the week commencing on the 12th day of December, 1980, any amount payable to him by way of that pension for that week shall be increased by a sum equal to that amount.

3.—Where a person is or becomes entitled to payment of the following benefit or any of the following pensions or allowances under the Social Welfare Acts, 1952 to 1980-

(a) old age (contributory) pension,

- (b) invalidity pension,
- (c) retirement pension,

Increase of pensions, deserted wife's benefit and certain allowances under Social Welfare Acts, 1952 to 1980, for week commencing 11th or 12th December, 1980.

 - (f) orphan's (contributory) allowance,

in respect of the week commencing on the 12th day of December, 1980, in the case of a pension or allowance mentioned in paragraph 10 (a), (d) or (f) of this section, or in respect of the week commencing on the 11th day of December, 1980, in the case of a pension, benefit or allowance mentioned in any other paragraph of this section, any amount payable to him by way of that pension, benefit or allowance (including any increases) for the appropriate week shall be increased assemble by 15 by a sum equal to that amount.

4.—(1) Where a person is or becomes entitled to payment of Increase of disablement pension under the Social Welfare (Occupational Injuries) Act, 1966, in respect of the week commencing on the 12th day of death benefit December, 1980, any amount payable to him by way of that pension by way of concluding any increases) for that week shall be increased by a sum spension under social Welfare equal to that amount.

(Occupational Injuries) Act, 1966, for week commencing 12th December, 1980.

(2) Where a person is or becomes entitled to payment of death benefit under the Social Welfare (Occupational Injuries) Act, 1966, by way of pension for a widow, widower, parent or orphan in respect 25 of the week commencing on the 12th day of December, 1980, any amount payable to him by way of that pension (including any increases) for that week shall be increased by a sum equal to that amount.

5.—This Act may be cited as the Social Welfare (Temporary Short title. 30 Provisions) Act, 1980.
