BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of
section 4 of Export
Promotion Act,
1959.

1.—The following subsection is hereby substituted for subsection
(1) of section 4 of the Export Promotion Act, 1959:

“(1) (a) It shall be the duty of the Board to promote, assist 10
and develop in any manner in which the Board con-
siders necessary or desirable the exportation of goods
and the provision of such services as are specified
from time to time by order made by the Minister.

(b) The Minister may by order amend or revoke an order 15
under this section.”.

Short title and
collective citation.

2.—(1) This Act may be cited as the Export Promotion (Amend-
ment) Act, 1982.

(2) The Export Promotion Acts, 1959 to 1980, and this Act may be
cited together as the Export Promotion Acts, 1959 to 1982. 20
