# BILL

AN ACT TO CONFER ON CERTAIN PERSONS CERTAIN 5  
RIGHTS TO VOTE AND FOR THAT PURPOSE TO  
AMEND SECTION 5 OF THE ELECTORAL ACT, 1963.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of  
section 5 of  
Electoral Act, 1963.

1.—Section 5 of the Electoral Act, 1963, is hereby amended by the 10  
insertion after subsection (1) of the following subsection:

“(1A) (a) In addition to those entitled to be registered under  
subsection (1) of this section, a person shall be  
entitled to be registered as a Dáil elector in a  
constituency if he is a person who has reached the  
age of eighteen years and who on the qualifying 15  
date—

(i) complied with the requirement of subsection  
(1) (b) of this section, and

(ii) was a British citizen.

(b) In this subsection ‘a British citizen’ means a person 20  
who under the Act of the British Parliament enti-  
tled ‘the British Nationality Act 1981’ is a British  
citizen.”.

Short title,  
construction and  
collective citation.

2.—(1) This Act may be cited as the Electoral (Amendment) Act, 25  
1983.

(2) This Act and the Electoral Acts, 1923 to 1980, shall be construed  
together as one Act and may be cited together as the Electoral Acts,  
1923 to 1983.
