BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

1.—Section 27 of the Copyright Act, 1963, is hereby amended by the substitution of the following subsections for subsections (9) and (10):

“(9) A person guilty of an offence under subsection (1) or (2) of this section shall be liable, on summary conviction—

(a) in case it is his first conviction of an offence under this section, to a fine not exceeding £50 for each article to which the offence relates;

(b) in any other case, to such a fine, or, at the discretion of the court, to imprisonment for a term not exceeding 6 months or to both such fine and such imprisonment;

so, however, that a fine imposed by virtue of this subsection shall not exceed £800 in respect of articles comprised in the same transaction.

(10) A person guilty of an offence under subsection (3) or (8) of this section shall be liable, on summary conviction—

(a) in case it is his first conviction of an offence under this section, to a fine not exceeding £800;

(b) in any other case, to such a fine, or, at the discretion of the court, to imprisonment for a term not exceeding 6 months or to both such fine and such imprisonment.”.
