AN ACT TO AMEND AND EXTEND THE SHANNON FREE
AIRPORT DEVELOPMENT COMPANY LIMITED ACTS,
1959 TO 1983.

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS: 10

Interpretation.

1.—(1) In this Act—

“the Act of 1983” means the Shannon Free Airport Development
Company Limited (Amendment) Act, 1983;

“the Company” means the Shannon Free Airport Development Com- 15
pany Limited;

“the Principal Act” means the Shannon Free Airport Development
Company Limited Act, 1959.

(2) The Shannon Free Airport Development Company Limited
Acts, 1959 to 1983, and this Act shall be construed as one.

Amendment of
section 2 of
Principal Act.

2.—So much of section 2 of the Principal Act (as amended by 20
section 2 of the Act of 1983) as provides that the aggregate of the
amounts which the Minister for Finance may subscribe under that
section in taking up shares of the Company shall not exceed
£120,000,000 is hereby repealed and, in lieu thereof, it is hereby
enacted that the aggregate of the amounts so subscribed shall not 25
exceed £130,000,000.

3.—Section 3 of the Act of 1983 is hereby repealed and, in lieu 30
thereof, it is hereby enacted that the aggregate amount of grants to
be made to the Company under section 8 of the Principal Act and
section 2 of the Shannon Free Airport Development Company Lim-
ited (Amendment) Act, 1970 (as amended by section 5 of the Act of
1983) shall not exceed £105,000,000.

Remuneration, etc.
of staff of Company.

4.—(1) There shall be paid by the Company to its officers and
servants, out of funds at its disposal, such remuneration and allowan-

ces as the Company, with the approval of the Minister given with the consent of the Minister for the Public Service, from time to time determines.

- 5 (2) An officer or servant of the Company shall hold office or employment on such terms and conditions as the Company, with the approval of the Minister given with the consent of the Minister for the Public Service, from time to time determines.

5.—(1) This Act may be cited as the Shannon Free Airport Development Company Limited (Amendment) Act, 1986.

- 10 (2) The Shannon Free Airport Development Company Limited Acts, 1959 to 1983, and this Act may be cited together as the Shannon Free Airport Development Company Limited Acts, 1959 to 1986. Short title,
