EXPLANATORY AND FINANCIAL MEMORANDUM-
ADDENDUM

Because of an amendment made by the Seanad on Committee Stage of the Bill, the following clarification of the Explanatory Memorandum of Meitheamh, 1986 is necessary in relation to *sections 58 and 59* of the Bill as now presented to the Dáil.

Section 58 is designed to deal with existing industrial plant which was licensable under the Control of Atmospheric Pollution Regulations, 1985 made under section 10 of the Local Government (Sanitary Services) Act, 1962. Until such time as plant of this kind is made licensable under Part III of this Bill, it will remain subject to the requirements of the earlier licensing system notwithstanding the repeal by this Bill of the statutory provisions involved.

The reference to *section 58* in the Explanatory Memorandum of Meitheamh, 1986 now relates to *section 59*, of the Bill as presented to the Dáil.
