AN ACT TO AMEND THE EXTRADITION (EUROPEAN CON-VENTION ON THE SUPPRESSION OF TERRORISM) ACT, 10

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of the Extradition (European Convention on the Suppression of Terrorism) Act, 1987

1.—The Extradition (European Convention on the Suppression of Terrorism) Act, 1987 is hereby amended by the insertion before 15 section 3, of the following new section:

"3.—Where a request is received for the extradition of a person under this Act, the requesting country shall be required to provide, before the District Court, evidence as to the commission by the person claimed of the offence for which extradition is sought, and extradition shall not be granted unless such evidence 20 produced establishes a prima facie case of involvement in the offence alleged.".

Short Title.

2.—This Act may be cited as the Extradition (European Convention on the Suppression of Terrorism) (Amendment) Act, 1987.
