BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

1.—The Extradition (European Convention on the Suppression of
Terrorism) Act, 1987 is hereby amended by the insertion before
section 3, of the following new section:

15

“3.—Where a request is received for the extradition of a
person under this Act, the requesting country shall be required to
provide, before the District Court, evidence as to the commission
by the person claimed of the offence for which extradition is
sought, and extradition shall not be granted unless such evidence
produced establishes a *prima facie* case of involvement in the
offence alleged.”.
