AN ACT TO AMEND THE CONSTITUTION. 5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 40 of the Constitution: 10

BE IT THEREFORE ENACTED BY THE OIREACHTAS AS FOLLOWS:

Amendment of
Article 40 of the
Constitution.

1.—Article 40 of the Constitution is hereby amended as follows:

(a) the section set out in *Part I* of the Schedule to this Act shall be substituted for section 1 of the Irish text, 15

(b) the section set out in *Part II* of the Schedule to this Act shall be substituted for section 1 of the English text.

Citation.

2.—(1) The amendment of the Constitution effected by this Act shall be called the Eleventh Amendment of the Constitution.

(2) This Act may be cited as the Eleventh Amendment of the Constitution Act, 1991. 20
