# BILL

AN ACT TO AMEND THE ÚDARÁS NA GAELTACHTA ACT,  
1979. 5

BE IT ENACTED BY THE OIREACHTAS AS FOLLOWS:

Definitions.

**1.—In this Act—**

“the Minister” means the Minister for Arts, Culture and the Gaeltacht;

“the Principal Act” means the Údarás na Gaeltachta Act, 1979; 10

“an tÚdarás” means Údarás na Gaeltachta.

Grants to an  
tÚdarás.

**2.—The Principal Act is hereby amended by the substitution of the following section for section 22:**

“22.—In each financial year there may be paid by the Minister to an tÚdarás out of moneys provided by the Oireachtas a grant or grants of such amount or amounts as the Minister, with the consent of the Minister for Finance, may fix to enable an tÚdarás to meet any expenditure incurred by it in the performance of its functions.”. 15

Advances to an  
tÚdarás.

**3.—(1)** Any advance made to an tÚdarás under section 23 of the Principal Act before the commencement of this Act shall not be repayable nor shall interest be payable thereon. 20

(2) Any advance made to Gaeltarra Éireann under the Gaeltacht Industries Acts, 1957 to 1977, after the 1st day of April, 1965, shall not be repayable nor shall interest be payable thereon. 25

(3) Subsection (1), paragraphs (a) and (c) of subsection (2) and subsections (3) and (4) of the said section 23 are hereby repealed.

**4.—(1)** This Act may be cited as the Údarás na Gaeltachta (Amendment) Act, 1993.

(2) The Údarás na Gaeltachta Acts, 1979 to 1989, and this Act may be cited together as the Údarás na Gaeltachta Acts, 1979 to 1993. 30

- 1.—San Acht seo—Mínithe.

- 10 ciallaíonn “an Príomh-Acht” an tAcht um Údarás na Gaeltachta, 1979;
- ciallaíonn “an tÚdarás” Údarás na Gaeltachta.

- 2.—Leasaítear leis seo an Príomh-Acht tríd an alt seo a leanas a chur in ionad alt 22:Deontais don Údarás.

- 15 “22.—I ngach bliain airgeadais féadfaidh an tAire deontas nó deontais, ina mbeidh cibé méid nó méideanna a shocróidh an tAire, le toiliú an Aire Airgeadais, a foc leis an Údarás as airgead a sholáthroidh an tOireachtas chun a chumasú don Údarás aon chaiteachas a foc a thabhairt sé le linn a fheidhmeanna a chomhlíonadh.”.

- 20 3.—(1) Ní bheidh aon airleacan a tugadh don Údarás faoi alt 23 Airleacain don Údarás.
- den Phríomh-Acht roimh thosach feidhme an Acht seo inaistíochta ná ní bheidh ús iniochta air.

- 25 (2) Ní bheidh aon airleacan a tugadh do Ghaeltarra Éireann faoi na hAchtanna um Thionscail na Gaeltachta, 1957 go 1977, tar éis an lú lá d'Aibreán, 1965, inaistíochta ná ní bheidh ús iniochta air.

- (3) Aisghairtear leis seo fo-alt (1), míreanna (a) agus (c) d'fho-alt (2) agus fo-ált (3) agus (4) den alt sin 23.

- 4.—(1) Féadfar an tAcht um Údarás na Gaeltachta (Leasú), 1993, a ghairm den Acht seo.Gearrtheideal, comhlua agus tosach feidhme.
- 30 (2) Féadfar na hAchtanna um Údarás na Gaeltachta, 1979 go 1993, a ghairm de na hAchtanna um Údarás na Gaeltachta, 1979 go 1989, agus den Acht seo le chéile.
