submissions).

2.—Section 10 of the Electoral Act 1997 is amended by the insertion after subsection (3) of the following subsection:

'(3A) Upon the expiry of the period for submissions provided for in the notice under subsection (1), the Commission shall publish on its website a copy of all submissions received on or before the expiry of that period, and shall thereupon give public notice that it will receive replying submissions or comments on such submissions within such further time as may be specified in the notice published under this subsection.'."
