1. In page 3, before section 2, to insert the following new section:

"Amendment to Act of 2006.

2.—The Act of 2006 is amended by the substitution of the words "mental disorder" for the word "insanity" in every instance where it occurs.".

- (7) A person who is arrested under subsection (6)* by a member of the Garda Siochána shall, as soon as practicable, be transferred into the custody of an officer or servant of the designated centre or an authorised person for the purpose of effecting the return of that person to the designated centre concerned."
