SECTION 3

1. In page 3, before section 3, to insert the following new section:

“3.—(1) Annual remuneration in respect of staff of the Houses of the Oireachtas Service shall be no more than €100,000 for an emergency period of three years from the date upon which this Bill is enacted.

- (2) Allowances in respect of staff of the Houses of the Oireachtas Service.”

2. In page 3, before section 3, to insert the following new section:

“3.—(1) The Taoiseach’s total remuneration shall be no more than €100,000.

(2) A Ministers total remuneration shall be no more than €100,000.

(3) A Minister of State’s remuneration shall be no more than €100,000.

(4) A TDs remuneration shall be no more than €75,000.”

“3.—Other allowances in respect of Members of Dáil Éireann with the exception of the Oireachtas Members’ Mobile Phone Allowance which is to be withdrawn and this provision shall come into effect immediately on the passing of this Act.”

4. In page 3, before section 3, to insert the following new section:

“3.—A Senators remuneration shall be no more than €60,000.”

“3.—Other allowances in respect of Members of Seanad Éireann with the exception of the Oireachtas Members’ Mobile Phone Allowance which is to be withdrawn and this provision shall come into effect immediately on the passing of this Act.”

6. In page 5, before section 4, to insert the following new section:

“Repeal of Statutory Instrument No. 28 of 2012.

4.—Statutory Instrument No. 28 of 2012 Oireachtas (Allowances) (Certain Ministers of State) Order 2012 (S.I. No. 28 of 2012) is repealed and this provision shall come into effect immediately on the passing of this Act.”
