- 2. The Government shall, no more than three months after the passing of this Act, introduce a Constitutional Amendment Bill seeking the following:
 - (1) To insert after Article 10, section 4 of the Constitution, the following section:
 - "5. No law, however, may be enacted providing for the transfer into private ownership of the public water supply.".
 - (2) The Amendment of the Constitution effected by this Act shall be called the Thirty-fourth Amendment of the Constitution.".

 - (a) a Resolution of each such House is passed approving a proposal to provide or allow for such alienation,
 - (b) a proposal to provide or allow for such alienation is submitted by Plebiscite for the decision of the People, and
 - (c) a majority of the votes cast in such Plebiscite shall have been cast in favour of the proposal.".

(17) Any reduction in revenues due to the implementation of <i>subsection</i> (16)* must come from existing Irish Water resources, such that there is no potential impact on the Exchequer of <i>subsection</i> (16)*."
