An Act to amend the Domestic Violence Act 1996 to provide protection to applicants who have been prohibited from availing of social housing by virtue of the applicant's legal or beneficial interest in the residence in which the applicant and respondent previously resided. 5

Be it enacted by the Oireachtas as follows:

Amendment of Domestic Violence Act 1996 10

1. The Domestic Violence Act 1996 is amended by inserting the following section after section 8:

“8A. An applicant shall not, by virtue of the applicant's legal or beneficial interest in the residence in which the applicant resides or previously resided with the respondent, be prohibited from consideration for social housing by a local authority.”. 15

2. This Act may be cited as the Domestic Violence (Amendment) Act 2014.
