# **Bill**

*entitled*

An Act to remove the power of Irish Water to request persons to provide Irish Water with their Personal Public Service numbers and for that purpose to amend the Social Welfare Consolidation Act 2005 and to provide for related matters. 5

**Be it enacted by the Oireachtas as follows:**

**Amendment of Social Welfare Consolidation Act 2005**

1. Schedule 5 to the Social Welfare Consolidation Act 2005 is amended in paragraph 1(4) by deleting “Irish Water,” (inserted by section 20 of the Social Welfare and Pensions Act 2014). 10

**Destruction of PPS data**

2. Irish Water shall, within 21 days of the passing of this Act, destroy all records which it holds of any Personal Public Service numbers which— 15
- (a) have been provided to Irish Water by customers, or
  - (b) have been acquired by Irish Water by any means,
- in advance of the passing of this Act.

**Short title**

3. This Act may be cited as the Social Welfare and Pensions (Amendment) Act 2014. 20
