# **Bill**

*entitled*

An Act to amend the Companies Act 2014 to hold a company officer or officers acting on behalf of a corporate body personally liable where a breach of employment law is committed. 5

**Be it enacted by the Oireachtas as follows:**

## **Definitions**

1. In this Act “Principal Act” means the Companies Act 2014. 10

## **Amendment to section 224 of the Principal Act**

2. Section 224 of the Principal Act is amended by the addition of a new subsection (3)—

“(3) Where a breach of employment law is committed by a body corporate or by a company officer or officers acting on behalf of a body corporate and is determined to have been so committed, with the consent, connivance or approval of, or to have been attributable to any neglect on the part of, a person or persons who, when the breach was committed was a company officer or officers of the body corporate, then that person or persons shall be personally liable for the breach committed.”. 15

3. This Act may be cited as the Companies (Amendment) Act 2015.
