An Act to establish a Public Order Unit for Dublin City Centre charged with improving and maintaining public order and safety in the Dublin City Centre area as set out by the Garda Commissioner. 5

Be it enacted by the Oireachtas as follows:

Interpretation

1. In this Act, “the Principal Act” refers to the Garda Síochána Act 2005. 10

Amendment of Principal Act

2. The Principal Act is amended by inserting after section 38 the following:

“38A.(1)A Special Public Order Unit will be established for Dublin City Centre. The unit will be tasked with:

- (a) maintaining and improving public safety in Dublin City Centre; 15
- (b) liaising with Dublin City Council, the Dublin Business Improvement District and other city centre bodies as may be designated by the Minister for Justice;
- (c) the Assistant Commissioner for the Dublin Metropolitan Region should be charged with reporting to Dublin City Council quarterly on the impact of the Public Order Unit; 20
- (d) the Garda Commissioner and Assistant Garda Commissioner should report to the Oireachtas annually on the Public Order Unit;
- (e) the operation of the Public Order Unit will be set by the Garda Commissioner; and 25
- (f) additional city centre units may be established by the Minister for Justice in consultation with the Garda Commissioner.”

Short title and commencement

3. (1) This Act may be cited as the Garda Síochána (Amendment) Act 2015.
- (2) This Act shall come into operation on the day that is three months after the day of its passing.

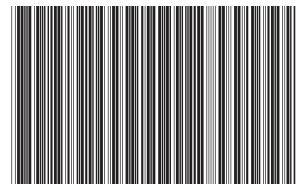
