# **Bill**

*entitled*

An Act to amend the Constitution.

5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 10 of the Constitution:

**Be it enacted by the Oireachtas as follows:**

**Amendment of Article 10 of the Constitution**

10

1. Article 10 of the Constitution is hereby amended as follows:

- (a) the section, the text of which is set out in *Part 1* of the *Schedule*, shall be inserted after section 4 of the Irish text; and
- (b) the section, the text of which is set out in *Part 2* of the *Schedule*, shall be inserted after section 4 of the English text.

**Citation**

2. (1) The amendment of the Constitution effected by this Act shall be called the Thirty-fifth Amendment of the Constitution.

(2) This Act may be cited as the Thirty-fifth Amendment of the Constitution (Water in Public Ownership) Act 2016.


