# Bill

*entitled*

An Act to amend the Constitution. 5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 28 of the Constitution:

**Be it therefore enacted by the Oireachtas as follows:**

**Amendment of Article 28 of Constitution** 10

1. Article 28 of the Constitution is hereby amended as follows:

- (a) the subsection, the text of which is set out in *Part 1* of the *Schedule*, shall be inserted after subsection 2 of section 4 of the Irish text;
- (b) the subsection, the text of which is set out in *Part 2* of the *Schedule*, shall be inserted after subsection 2 of section 4 of the English text; and 15
- (c) subsections 3 and 4 of section 4 of both texts shall be numbered as subsections 4 and 5.

**Citation**

- 2. (1) The new Article effected by this Act shall be called the Thirty-fifth Amendment of the Constitution. 20
- (2) This Act may be cited as the Thirty-fifth Amendment of the Constitution (Water in Public Ownership) Act 2016.


