An Act to amend the Health (Pricing and Supply of Medical Goods) Act 2013 to allow interchangeability between biologic and biosimilar medical goods.

Be it enacted by the Oireachtas as follows:

Interpretation

10

1. In this Act—

“Act of 2013” means the Health (Pricing and Supply of Medical Goods) Act 2013.

Amendment of section 5 of Act of 2013

2. Section 5 of the Act of 2013 is amended by the deletion of subsection (7)(d).

Amendment of section 13 of Act of 2013

3. Section 13 of the Act of 2013 is amended by the insertion of the following at the end of subsection (1):

“Notwithstanding the provision contained in this subsection, in the case of a new patient seeking a treatment for the first time, where a prescriber is satisfied that a medicinal product can be substituted in accordance with Chapter 2, the prescriber shall have the discretion to waive the clinical exemption and substitute accordingly.”.

Short title and commencement

4. (1) This Act may be cited as the Health (Pricing and Supply of Medical Goods) (Amendment) Act 2016.

(2) This Act comes into operation on such day or days as the Minister for Health may appoint by order or orders.

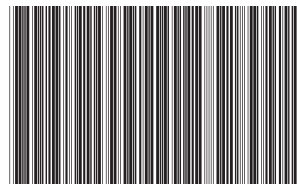
