WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed to amend Article 40 of the Constitution:

Be it enacted by the Oireachtas as follows:

Amendment of Article 40 of Constitution

10

1. Article 40 of the Constitution is hereby amended as follows:

- (a) subsection 3 of section 3 of the Irish text shall be deleted; and
- (b) subsection 3 of section 3 of the English text shall be deleted.

Citation

2. (1) The amendment of the Constitution effected by this Act shall be called the Thirty-fifth Amendment of the Constitution.
- (2) This Act may be cited as the Thirty-fifth Amendment of the Constitution (Repeal of the Eighth Amendment) Act 2016.

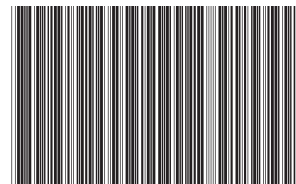
