SECTION 1
ALT 1

1. In page 4, to delete lines 12 to 19 and substitute the following:

- “(a) the subsection, the text of which is set out in *Part 1* of the *Schedule*, shall be substituted for subsection 2^o of section 3 of the Irish text;
- (b) the subsection, the text of which is set out in *Part 2* of the *Schedule*, shall be substituted for subsection 2^o of section 3 of the English text;”.
