An Act to provide for a prohibition on legislation which would unilaterally impose a levy, or similar charge, on pension funds. 5

Be it enacted by the Oireachtas as follows:

Prohibition of levies

1. No legislation, Statutory Instrument, or Ministerial Directive shall be proposed or accepted which would allow the Stamp Duties Consolidation Act 1999, the Taxes Consolidation Act 1997, any amendments to those Acts, or any similar existing or future legislation, to provide for a Stamp Duty Levy, or any similar charge, to be unilaterally applied to pension funds legitimately set up under appropriate pension legislation. 10

Short title and commencement

2. (1) This Act may be cited as the Pension Fund (Prohibition of Levies) Act 2016. 15
(2) This Act shall come into operation by order made by the Minister for Finance within 21 days of its passing.

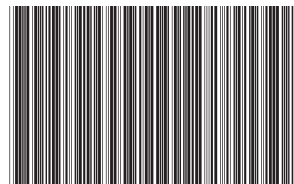
