An Act to remove certain functions from the Citizens Information Board; to amend the Comhairle Act 2000; and to provide for related matters.

Be it enacted by the Oireachtas as follows:

Definitions

1. In this Act—

“Act of 2008” means the Social Welfare (Miscellaneous Provisions) Act 2008;

“Board” means the Citizens Information Board;

“Minister” means the Minister for Employment Affairs and Social Protection;

“Principal Act” means the Comhairle Act 2000.

Repeal of Part 4 of Act of 2008

15

2. (1) Part 4 of the Act of 2008 is repealed.

(2) Section 2 of the Principal Act is consequently amended—

(a) in the definition of “voluntary body” by deleting “a money advice and budgeting service,”, and

(b) in the definition of “social service” by deleting “advice on personal debt and money management”. 20

(3) Section 7 of the Principal Act is consequently amended—

(a) in subsection (1) by deleting paragraphs (ca) to (ch),

(b) in subsection (2)—

(i) in paragraph (a), by substituting “subsection (1), and” for “subsection (1),” 25

(ii) by deleting paragraph (aa),

(iii) in paragraph (b), by substituting “subsection (1)(h),” for “subsection (1)(h), and”,

(iv) by deleting paragraph (ba),

- (v) by substituting “may apply under paragraphs (a) and (b)” for “may apply under paragraphs (a), (aa), (b) and (ba)”,
- (c) in subsection (2)—
 - (i) by substituting “paragraph (a) of subsection (2)” for “paragraphs (a) and (aa) of subsection (2)”, and 5
 - (ii) by substituting “paragraph (b) of that subsection” for “paragraphs (b) and (ba) of that subsection”,
- (d) in subsection (2)—
 - (i) by substituting “paragraph (a) of subsection (2)” for “paragraphs (a) and (aa) of subsection (2)”, and 10
 - (ii) by substituting “paragraph (b) of that subsection” for “paragraphs (b) and (ba) of that subsection”,

and

 - (e) by deleting subsection (2).
- (4) Section 25A of the Principal Act is consequently repealed. 15

Repeal of section 1(5) of Act of 2008

- 3. Section 1(5) of the Act of 2008 is repealed.

Short title and collective citation

- 4. (1) This Act may be cited as the Social Welfare (Miscellaneous Provisions)(Amendment) Act 2017. 20
- (2) The Citizens Information Acts 2000 and 2007 and this Act may be cited together as the Citizens Information Acts 2000 to 2017.
