An Act to amend the Courts Service Act 1998 to prohibit investments by the Courts Service in tobacco related companies and to provide for related matters. 5

Be it enacted by the Oireachtas as follows:

Interpretation

1. In this Act—

“Courts Service” means the body established by section 4(1) of the Courts Service Act 1998; 10

“investment” means the moneys invested by the Courts Service on behalf of wards of court and of children under 18 years of age who have received significant court awards;

“tobacco company” means a company involved in the production or manufacture of tobacco, cigarettes, cigars and other tobacco products; 15

“tobacco product” has the same meaning assigned to it by the Public Health (Tobacco) Act 2002.

Prohibition of investment in a tobacco company by the Courts Service

2. (1) It shall be illegal for the Courts Service to hold an investment in a tobacco company.

(2) Upon compliance with this Act, the Courts Service will issue a formal notification to the representatives of all wards of courts, and to the parents or guardians of children under 18 years of age who have received awards from the courts, to confirm that their money is no longer invested in the tobacco industry. 20

Short title and commencement

3. (1) This Act may be cited as the Courts Service (Amendment) Act 2017. 25

(2) This Act shall come into operation on the day of its passing.
