An Act to provide for the growth of electricity production from micro-generators through a supplier obligation to provide a tariff for electricity exported to the grid. 5

Be it enacted by the Oireachtas as follows:

Electricity suppliers

1. Electricity suppliers above 10 per cent market share shall provide a payment for KWh of electricity exported to the grid from domestic micro-generators. 10

Micro-generation power

2. Micro-generation may include—
 - (a) small scale wind power,
 - (b) photovoltaic (solar),
 - (c) combined heat-and-power (CHP) using renewable sources, 15
 - (d) small scale hydroelectric,
 - (e) and such other technology as may be added by the Minister under Regulation.

Minimum price tariff

3. A minimum price tariff will be applied across all suppliers from micro-generators.

Regulations

4. (1) The Minister shall draft Regulations that may be revised which will contain:
 - (a) minimum contractual price which a supplier must offer to a domestic micro-generators taking account of the different microgeneration technology types listed, 20
 - (b) minimum length of contractual term for tariff, 25
 - (c) Minister can amend the applicable micro-generation equipment and generation capacity.

- (2) Electricity suppliers under this Act must supply 5 per cent of their electricity from microgeneration by 2025.
- (3) Community projects containing a minimum of 5 households may also apply to an electricity supplier under this Act.

Short title and commencement

- 5. (1) This Act may be cited as the Microgeneration Support Scheme Act 2017.
- (2) This Act shall come into operation on such day or days as the Minister may appoint.
