An Act to amend the Public Transport Regulation Act 2009.

Be it enacted by the Oireachtas as follows:

Amendment of Public Transport Regulation Act 2009

- 1. Subsection (3) of section 10 (General provisions for the consideration of applications for grant of licences) of the Public Transport Regulation Act 2009 is amended—
 - (a) in paragraph (b) by deleting "and" where it secondly appears,
 - (b) in paragraph (c) by substituting "Taxes Consolidation Act 1997," for "Taxes Consolidation Act 1997.", and
 - (c) by inserting the following as paragraph (d):
 - "(d) bearing in mind the importance of a well-functioning and reliable public transport system and the consequent need for harmonious 15 industrial relations and the avoidance of industrial unrest, he or she will—
 - (i) engage in collective bargaining (within the meaning of section 1A of the Industrial Relations (Amendment) Act 2001), with the object of reaching agreement regarding working conditions and 20 terms of employment of workers employed by the applicant in the operation of the service, or
 - (ii) become a member of an association, representative of employers in the sector, which agrees that it is expedient to have terms and conditions relating to remuneration, sick pay schemes and 25 pension schemes in respect of workers in the sector from time to time examined by the Labour Court under section 15 of the Industrial Relations (Amendment) Act 2015.".

Short title, collective citation and construction

- 2. (1) This Act may be cited as the Public Transport Regulation (Amendment) Act 2017.
 - (2) This Act and the Public Transport Regulation Act 2009 may be cited together as the Public Transport Regulation Acts 2009 and 2017 and shall be construed together as
