An Act to amend the Equal Status Act 2000 to amend section 7(3) of that Act so that 5 school admission policies in publicly funded schools may not discriminate against children on the basis of religious beliefs.

Be it enacted by the Oireachtas as follows:

Interpretation

1. In this Act, the "Principal Act" means the Equal Status Act 2000.

Amendment of section 7(3) of Principal Act

- 2. Section 7(3) of the Principal Act is amended by inserting the following paragraph after paragraph (c)—
 - "(ca) paragraph (c) shall not apply to schools which are maintained, in whole or in part, by monies provided by the Oireachtas,".

Short title, collective citation and construction

- **3.** (1) This Act may be cited as the Equal Status (Amendment) Act 2017.
 - (2) The Equal Status Acts 2000 to 2015 and this Act may be cited together as the Equal Status Acts 2000 to 2017 and shall be construed together as one.
