An Act to provide for democratic elections to Údarás na Gaeltachta and for related matters.

Be it enacted by the Oireachtas as follows:

Interpretation

1. In this Act—

“Minister” means the Minister for Arts, Heritage, Regional, Rural and Gaeltacht Affairs;

“Principal Act” means the Údarás na Gaeltachta Act 1979.

Amendment of section 6 of Principal Act

2. Section 6 of the Principal Act is hereby amended by the substitution of the following subsection for subsection (2):

“(2) An tÚdarás shall consist of a chairperson who shall be appointed by the Minister and 19 other members of whom 17 shall be persons elected in accordance with Part IV of this Act and 2 shall be appointed by the Minister.”.

Amendment of section 29 of Principal Act

3. The Principal Act is hereby amended by the substitution of the following section for section 29:

“**29.** (1) Each of the following areas shall be a constituency for the purposes of this Part:

(a) the area comprising those parts of the Gaeltacht situated in the county of Donegal,

(b) the area comprising those parts of the Gaeltacht situated in the county of Mayo,

(c) the area comprising those parts of the Gaeltacht situated in the county of Galway,

“(2) Is iad a bheidh ar an Údarás cathaoirleach, a gceapfaidh an tAire é nó í, agus 19 gcomhalta eile ar daoine a thoghfar de réir Chuid IV den Acht seo 17 nduine díobh agus ar daoine a gceapfaidh an tAire iad 2 dhuine díobh.”.

Leasú ar alt 29 den Phíomh-Acht

3. Leasaítear leis seo an Príomh-Acht tríd an alt seo a leanas a chur in ionad alt 29:

“29. (1) Is toghlach chun críocha na Coda seo gach limistéar díobh seo a leanas:

(a) an limistéar arb é na codanna sin den Ghaeltacht é atá i gcontae Dhún na nGall,

(b) an limistéar arb é na codanna sin den Ghaeltacht é atá i gcontae Mhaigh Eo,

(c) an limistéar arb é na codanna sin den Ghaeltacht é atá i gcontae na Gaillimhe,

- (d) the area comprising those parts of the Gaeltacht situated in the county of Meath,
 - (e) the area comprising those parts of the Gaeltacht situated in the county of Kerry,
 - (f) the area comprising those parts of the Gaeltacht situated in the county of Cork, and 5
 - (g) the area comprising those parts of the Gaeltacht situated in the county of Waterford.
- (2) In an election—
- (a) the constituency specified in subsection (1)(a) shall return 4 10 persons,
 - (b) the constituency specified in subsection (1)(b) shall return 2 persons,
 - (c) the constituency specified in subsection (1)(c) shall return 6 15 persons,
 - (d) the constituency specified in subsection (1)(d) shall return 1 person,
 - (e) the constituency specified in subsection (1)(e) shall return 2 persons,
 - (f) the constituency specified in subsection (1)(f) shall return 1 person, 20 and
 - (g) the constituency specified in subsection (1)(g) shall return 1 person.”.

Amendment to First Schedule of Principal Act

4. The First Schedule to the Principal Act is amended— 25
- (a) by the substitution of the following for paragraph 2:
- “A member of an tÚdarás other than a member appointed in accordance with section 6(2)(a)(vi) shall, unless the member sooner dies, resigns, becomes disqualified or is removed from office, hold office for such period not exceeding five years.”, 30
- (b) by the deletion of paragraph 3.

Short title, collective citation and commencement

5. (1) This Act may be cited as the Údarás na Gaeltachta (Amendment) Act 2017.
- (2) This Act shall come into operation on the date of its passing.
- (3) This Act and the Údarás na Gaeltachta Act 1979 may be cited together as the Údarás 35 na Gaeltachta Acts 1979 and 2017 and shall be construed together as one Act.

- (f) toghfaidh an toghlach a shonraítear i bhfo-alt (1)(f) duine amháin,
- agus
- (g) toghfaidh an toghlach a shonraítear i bhfo-alt (1)(g) duine 20
- amháin.”.
