An Act to amend and extend the Road Traffic Acts 1961 to 2016 to give Gardaí the power to seize and detain quad bikes and scrambler motorcycles when being used unlawfully and to provide for related matters.

Be it enacted by the Oireachtas as follows:

Interpretation

10

1. In this Act—

“Act of 1994” means the Road Traffic Act 1994;

“Minister” means the Minister for Transport, Tourism and Sport.

Amendment of section 41 of Act of 1994

2. Section 41 of the Act of 1994 is hereby amended by the insertion of the following subsections after subsection (5):

“(6) In this section “public place” includes—

(a) any public road,

(b) any street road or other place to which the public have access with vehicles whether as of right or by permission and whether subject to or free of charge, and

(c) any outdoor area including public parks to which members of the public have or are permitted to have access, whether as of right or as a trespasser or otherwise and which is used for public recreational purposes.

(7) Notwithstanding the generality of subsection (1), the Minister may make regulations authorising and providing for the detention, removal, storage and subsequent release or disposal of scrambler motorbikes and or quad bikes for any of the reasons set out in subsection (1).”.

Short title, collective citation and commencement

3. (1) This Act may be cited as the Road Traffic (Quads and Scramblers) (Amendment) Act 2017.
- (2) This Act and the Road Traffic Acts 1961 to 2016 and may be cited together as the Road Traffic Acts 1961 to 2017.
- (3) This Act shall come into operation on such day or days as the Minister may appoint by order or orders either generally or with reference to any particular purpose or provision and different days may be so appointed for different purposes or different provisions.
