	"(iv) in paragraph (k), by the insertion of "including safety implications arising from neighbouring states nuclear programmes" after "fit",".

	"(iv) by the insertion of the following paragraph after paragraph (k):
	"(l) to report annually to the Oireachtas on the implementation of the National Radon Control Strategy or any successor strategy.",".

	"(c) in paragraph (h), by the insertion of "and the Oireachtas" after "as appropriate",".

	"(n) to advise the Government, the Minister and other Ministers regarding the risks to the Irish environment, population, society and economy from ionising radiation and radiation sources in countries with military nuclear programmes and/or nuclear energy programmes, including the risks of accidental or unplanned releases of radioactive materials;"."

5.	In page 13, line 21, after "origin" to insert "including a survey of homes across the State in areas deemed most at risk to radon exposure".

- **6.** In page 13, between lines 21 and 22, to insert the following:
  - "(b) the insertion of the following subsection after subsection (1):
    - "(1A) The Minister shall establish a scheme of remediation of homes across the State with unsafe levels of radon gas.",".

- 7. In page 13, between lines 26 and 27, to insert the following:
  - "(c) the insertion of the following subsection after subsection (2):
    - "(2A) The Minister shall make regulations to require that landlords test for radon in rented living accommodation where residents may be exposed to elevated radon concentrations and to require remediation works where appropriate.",".

**8.** In page 13, line 28, to delete "(2A) In making regulations under subsection (1) or (2)" and substitute "(2B) In making regulations under subsection (1), (2) or (2A)\*".

- **9.** In page 25, between lines 2 and 3, to insert the following:
  - "(c) in subsection (4), by the insertion of the following paragraph after paragraph (n):
    - "(o) any other licence, registration, permit, permission, lease, approval, certification or consent which is intended to, or contains one or more requirements, conditions or other elements intended to prevent, avoid, alleviate, mitigate or remedy damage to the environment.","

- **10.** In page 25, between lines 2 and 3, to insert the following:
  - "(c) in subsection (4), by the insertion of the following paragraph after paragraph (n):
    - "(o) any proceedings where such a licence, registration, permit, permission, lease, approval, certification or consent should have been in place or have been applied for, and any proceedings where this is a question at issue.",".
