Be it enacted by the Oireachtas as follows:

Definition

1. In this Act—

"Act of 2004" means the Civil Liability and Courts Act 2004.

- 2. Section 26 of the Act of 2004 is amended by—
 - (a) the insertion of subsection (5) after section 26(4):
 - "(5) Where the court dismisses an action pursuant to this section, the court shall direct that the transcript of the action and any relevant evidence is sent to the Director of Public Prosecutions."

Short title and commencement

- **3.** (1) This Act may be cited as the Civil Liability and Courts (Amendment) Act 2018.
 - (2) This Act shall come into operation on such day or days as the Minister may appoint by order or orders either generally or with reference to any particular purpose or provision and different days may be so appointed for different purposes or different provisions.
