Be it enacted by the Oireachtas as follows:

Amendment of section 3 of Charities Act 2009

1. Section 3 of the Charities Act 2009 is amended—

(a) in subsection (1) by the the substitution of the following for paragraph (c): 10

“(c) the advancement of human rights;”,

and

(b) by the deletion of subsections (4), (5) and (6).

Short title and collective citation

2. (1) This Act may be cited as the Charities (Human Rights) Act 2018. 15

(2) This Act and the Charities Act 2009 may be cited together as the Charities Act 2009 to 2018 and shall be construed together as one Act.
