An Act to amend the Criminal Justice Act 2006 to increase the sentence for persons convicted of conspiring or soliciting to commit murder. 5

Be it enacted by the Oireachtas as follows:

Definition

1. In this Act—

“Act of 1861” means the Offences Against the Person Act 1861; 10

“Act of 2006” means the Criminal Justice Act 2006.

Amendment of section 71 of Act of 2006

2. Section 71 of the Act of 2006 is amended by the insertion of the following after subsection (4):

“(5) If the serious offence for which a person is convicted under subsection (1) is the offence of conspiracy to murder under section 4 of the Act of 1861, then notwithstanding any provision contained within that Act, the person convicted is liable on conviction to imprisonment for life.”. 15

Short title, citation and commencement

3. (1) This Act may be cited as the Criminal Justice (Conspiracy to Murder) Act 2019. 20

(2) This Act shall come into operation on such day or days as the Minister may appoint by order.
