An Act to amend the Road Traffic Act 1961 to further regulate the use of all terrain vehicles and scrambler motor-cycles in a public place, to make further provision for the seizure, by An Garda Síochána, of said vehicles and motorcycles in certain circumstances, to provide for the confiscation and disposal of same when a person contravenes the law in relation to the use of both all terrain vehicles and scrambler motor-cycles in a public place and to provide for related matters. 10

Be it enacted by the Oireachtas as follows:

Interpretation

1. In this Act, save where the context otherwise requires— 15
- “all terrain vehicle” includes a mechanically propelled vehicle referred to as a quad, quad bike, three-wheeler, four-track, four-wheeler, quadricycle and/or a vehicle that travels on low-pressure tyres, with a seat that is straddled by the operator, along with handlebars for steering control;
- “Minister” means the Minister for Transport, Tourism and Sport; 20
- “National Vehicle and Driver File (NVDF)” means the database containing details of all registered vehicles and their owners as well as licensed drivers in the State, which system is maintained and supported by the Driver and Vehicle Computer Services Division of the Department of Transport, Tourism and Sport;
- “scrambler motor-cycle” includes a mechanically propelled vehicle that includes a lightweight motor-cycle equipped with rugged tyres and suspension, an off-road motor-cycle designed for riding cross country or over unpaved ground, a dirt bike and/or a trail bike; 25
- “vehicle registration plate” has the same meaning as it has in S.I. No. 318/1992 – Vehicle Registration and Taxation Regulations, 1992. 30

Seizure and disposal of scrambler motor-cycle and/or all terrain vehicle

2. (1) Where a member of An Garda Síochána is of the opinion that either—

- (a) a scrambler motor-cycle, or
- (b) an all terrain vehicle,

is being or has been ridden by any person, in a public place, pursuant to either or both the Road Traffic Act 1961 and the Criminal Justice (Public Order) Act 1994, without displaying a clearly visible and clearly legible vehicle registration plate, the said member may seize and retain such scrambler motor-cycle or all terrain vehicle. 5

- (2) Property seized in accordance with *subsection (1)* shall be disposed of in accordance with section 1 of the Police (Property) Act 1897 and section 25 of the Criminal Justice Act 1951.

Amendment of section 53 of Road Traffic Act 1961 10

3. Section 53 of the Road Traffic Act 1961 (as amended) is amended—

- (a) by the substitution of the following for subsection (2)(b):

“(b) in any other case, he or she is liable, on summary conviction, to—

- (i) a class A fine and/or confiscation of the vehicle,
- (ii) imprisonment for a term not exceeding 6 months, or 15
- (iii) both (i) and (ii).”

- (b) by the insertion of the following after subsection (2):

“(2A) Property confiscated in accordance with subsection (2) shall be disposed of in accordance with section 1 of the Police (Property) Act 1897.” 20

and

- (c) by the insertion of the following new subsections:

“(7) Where the vehicle to which an offence under subsection (1) relates is either an all terrain vehicle or a scrambler motor-cycle, the member of An Garda Síochána may seize the vehicle. 25

(8) Property seized in accordance with subsection (1) shall be disposed of in accordance with section 1 of the Police (Property) Act 1897 and section 25 of the Criminal Justice Act 1951.”

Amendment of section 30 of Road Traffic Act 2004

4. Section 30 of the Road Traffic Act 2004 (as amended) is amended— 30

- (a) by the substitution of the following for subsection (2):

“(2) A person who contravenes subsection (1) commits an offence and is liable, on summary conviction, to—

- (a) a class A fine and/or confiscation of the mechanically propelled vehicle, or 35

- (b) imprisonment for a term not exceeding 6 months, or

(c) both (a) and (b).”,

and

(b) by the insertion of the following:

“(2A) Property confiscated in accordance with subsection (2) shall be disposed of in accordance with section 1 of the Police (Property) Act 1897 and section 25 of the Criminal Justice Act 1951.”. 5

Amendment of Criminal Justice (Public Order) Act 1994

5. The Criminal Justice (Public Order) Act 1994 is amended by the insertion of the following:

“Riding an all terrain vehicle/scrambler motor-cycle dangerously in a public place 10

6A. (1) It shall be an offence for any person, to ride an all terrain vehicle or scrambler motor-cycle dangerously, in a public place, which having regard to all the circumstances, is likely to cause serious offence, annoyance or upset, to any person who is, or might reasonably be expected to be, aware of such behaviour. 15

(2) A person who is guilty of an offence under this section shall be liable, on summary conviction, to—

(a) a class A fine and/or confiscation of the vehicle,

(b) imprisonment for a term not exceeding 6 months, or 20

(c) both (a) and (b).”.

Regulations

6. (1) The Minister shall, within three months of the enactment of this Act, and, after consultation with the Minister for Justice, make regulations authorising and providing for the removal from the curtilage of a dwelling (but not including a dwelling) and subsequent disposal of either a scrambler motor-cycle or an all terrain vehicle, that in the opinion of a member of An Garda Síochána, on the balance of probabilities, is being used or has been used to commit an offence under this Act. 25

(2) The Minister shall, within six months of the enactment of this Act, and after consultation with the Minister for Finance, issue a report on the establishment of a database of all All Terrain Vehicles in the State, both new and second hand, with a view to ensuring all such vehicles be registered on the National Vehicle Driver File. 30

(3) The Minister may make regulations for the general purpose of this Act and may, by regulation, provide for any matter referred to in this Act as prescribed or to be prescribed. 35

(4) Every regulation under this Act shall be laid before each House of the Oireachtas as soon as may be after it is made and, if a resolution annulling the regulation is passed by either such House within the next 21 days on which that House has sat after the regulation is laid before it, the regulation shall be annulled accordingly but without prejudice to the validity of anything previously done under the regulation. 40

- (5) Regulations under this Act may contain such incidental, supplementary and consequential provisions as appear to the Minister to be necessary or expedient for the purposes of the regulations.

Short title and citation

7. (1) This Act may be cited as the Road Traffic (All Terrain Vehicle and Scrambler Motorcycle) (Amendment) Act 2019. 5
- (2) This Act shall come into operation on such day as may be fixed by order of the Minister.
