# Bill

*entitled*

An Act to provide for the establishment of *Taisceadán*, a Register of items of personal property to be managed by An Garda Síochána to assist in the identification of items of personal property, for the purposes of investigation of crime, for the repatriation of items of property and to provide for related matters. 5

**Be it enacted by the Oireachtas as follows:**

## **Interpretation**

10

1. In this Act, unless the context otherwise requires—

“Garda Commissioner” means the Commissioner of the Garda Síochána;

“Minister” means the Minister for Justice, Equality and Law Reform.

## **Establishment of Register**

2. (1) The Minister shall, as soon as is practicable after the commencement of this section, task the Garda Commissioner with establishing and maintaining a register of valuable property in the State to enable members of the public to register items of personal property. 15

(2) The Register shall be used by An Garda Síochána to assist in the detection of crime and to assist in the return of items of property to the lawful owners. An Garda Síochána may coordinate the use of this register with other related EU databases such as the CESAR system, as appropriate, and where proportionate. 20

(3) The items of property in question in *subsection (1)* shall relate to mobile property, such as, but is not limited to Mobile phones, Tablets/iPads, Bicycles, Games consoles, Watches/Jewellery, Computers/Laptops, Cameras, Luggage, Keys, Power tools, Antiques/collectable items, TV/Hi-Fi/Home entertainment equipment, as opposed to fixed property such as land or buildings. 25

(4) The information to be included in the Register may include but is not limited to—

(a) ownership details,

(b) trade history of the item,

(c) insurance details of the item. 30

- (5) Notwithstanding the generality of *subsection (4)* a person may, when registering an item pursuant to *subsection (1)* mark by stencil, by Telesis or by another means and make known such marks of identification when registering the item.

### **Regulations**

3. (1) The Minister may make regulations under this section to provide for the establishment of the Register as provided for in *section 2* and for the procedures for registering items of valuable property once the Register has been established. 5
- (2) Without prejudice to any provision of this Act, regulations under this section may contain such incidental, supplementary and consequential provisions as appear to the Minister to be necessary or expedient for the purposes of this Act. 10

### **Short title and commencement**

4. (1) This Act may be cited as the Taisceadán (Valuable Property Register) Act 2019.
- (2) This Act shall come into operation on such day or days as may be fixed by order of the Minister.

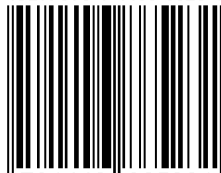
