An Act to amend the Constitution.

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution  
may be amended in the manner provided by that Article:

AND WHEREAS it is proposed—

(A) to amend Article 12 of the Constitution; and

(B) in consequence of the foregoing, to amend otherwise the Constitution for the  
purpose of giving effect to the amendment of Article 12:

**Be it therefore enacted by the Oireachtas as follows:**

**Amendment of Article 12 of the Constitution**

1. Article 12 of the Constitution is hereby amended as follows:

- (a) the subsection, the text of which is set out in *Part 1* of *Schedule 1*, shall be substituted for subsection 2° of section 2 of the Irish text;
- (b) the subsection, the text of which is set out in *Part 2* of *Schedule 1*, shall be substituted for subsection 2° of section 2 of the English text;
- (c) the subsection, the text of which is set out in *Part 1* of *Schedule 2*, shall be substituted for subsection 3° of section 3 of the Irish text;
- (d) the subsection, the text of which is set out in *Part 2* of *Schedule 2*, shall be substituted for subsection 3° of section 3 of the English text.

- (2) This Act may be cited as the Thirty-ninth Amendment of the Constitution (Presidential Elections) Act 2019.

## ARTICLE 12A

1. As soon as practicable after the enactment of this Article, a law providing for the exercise of the right to vote at elections for the office of President in accordance with the amendment of sections 2 and 3 of Article 12 hereof made by *section 1 of the Thirty-ninth Amendment of the Constitution (Presidential Elections) Act 2019* shall be enacted. 30
2. Notwithstanding Article 46 of this Constitution, the amendment of sections 2 and 3 of Article 12 hereof made by *section 1 of the Thirty-ninth Amendment of the Constitution (Presidential Elections) Act 2019* shall take effect on the 1st day of January 2025. 35

3. Where an election for the office of President is held prior to the 1st day of January 2025—

(i) Article 12.2.2° of this Constitution shall be read as follows:

“Every citizen who has the right to vote at an election for members of Dáil Éireann shall have the right to vote at an election for President.”,

and

(ii) Article 12.3.3° of this Constitution shall be read as follows:

“An election for the office of President shall be held not later than, and not earlier than the sixtieth day before, the date of the expiration of the term of office of every President, but in the event of the removal from office of the President or of his death, resignation, or permanent incapacity established as aforesaid (whether occurring before or after he enters upon his office), an election for the office of President shall be held within sixty days after such event.”.

4. This Article shall be omitted from every official text of this Constitution published after the 1st day of January 2025.

3. Where an election for the office of President is held prior to the 1st day of January 2025—

(i) Article 12.2.2° of this Constitution shall be read as follows:

“Every citizen who has the right to vote at an election for members of Dáil Éireann shall have the right to vote at an election for President.”,

and

(ii) Article 12.3.3° of this Constitution shall be read as follows:

“An election for the office of President shall be held not later than, and not earlier than the sixtieth day before, the date of the expiration of the term of office of every President, but in the event of the removal from office of the President or of his death, resignation, or permanent incapacity established as aforesaid (whether occurring before or after he enters upon his office), an election for the office of President shall be held within sixty days after such event.”.

4. This Article shall be omitted from every official text of this Constitution published after the 1st day of January 2025.
