An Act to provide for the provision of data by television broadcasting service providers for the purpose of assisting in the recovery of television licence fees; and to provide for connected matters. 5

Be it enacted by the Oireachtas as follows:

Amendment of Part 9 of Broadcasting Act 2009

1. Part 9 of the Broadcasting Act 2009 is amended by the insertion of the following section after section 145: 10

“Collection of licence fees: provision of television service subscription lists

145A. (1) On being requested to do so by the issuing agent, a television broadcasting service provider shall make available to the issuing agent such data kept by the television broadcasting service provider, or such information extracted from that data, as the issuing agent may reasonably require for the purpose of assisting in— 15

- (a) the identifying of persons who may have television sets not authorised by a licence for the time being in force, or
- (b) the performance of any other functions conferred on the issuing agent under this Part. 20

(2) Data made available to the issuing agent under subsection (1) may be processed by it for the purposes referred to in that subsection.

(3) In this section—

‘data’ includes personal data; 25

‘data’, ‘personal data’ and ‘processing’ have the meanings assigned to them by the Data Protection Acts 1988 to 2018;

‘television broadcasting service provider’ means a person who transmits, relays or distributes, by means of—

- (a) wireless telegraphy, 30
- (b) a cable system,

(c) a multipoint microwave distribution system,

(d) a satellite device,

(e) the Internet, or

(f) any other transmission system,

directly or indirectly for reception by the general public, a television programme service for the reception of which a charge is made.” 5

Short title, collective citation and construction

2. (1) This Act may be cited as the Broadcasting (Television Licence Fees Recovery) Act 2019.

(2) This Act and Part 9 of the Broadcasting Act 2009 may be cited together as the Broadcasting (Television Licence) Acts 2009 and 2019 and shall be construed together as one Act. 10
