An Act to amend the Litter Pollution Act 1997 to make it an offence for a person in charge of a dog in a public area to fail to produce a suitable bag or instrument to properly dispose of dog faeces when requested to do so by a dog warden, litter warden, or member of An Garda Síochána.

Be it enacted by the Oireachtas as follows:

Amendment of section 22 of Litter Pollution Act 1997

1. The Act of 1997 is amended by the insertion of the following subsection after subsection (4)—

“(5) Any person in charge of a dog in a public area who fails to produce a suitable bag or instrument to properly dispose of dog faeces when requested to do so by a dog warden, litter warden, or member of An Garda Síochána, shall be guilty of an offence.”
