An Act to amend the Waste Management Act 1996 to require the Minister to produce a report on the appointment of an independent regulator for the domestic waste management sector, including the regulation of domestic waste charges. 5

Be it enacted by the Oireachtas as follows:

Amendment of section 45 of Waste Management Act 1996

1. The Waste Management Act 1996 is amended in section 45 by the insertion of the following subsection after subsection (5): 10

“(6) The Minister shall, not later than 3 months after the passing of the *Waste Management (Amendment) (Regulator) Act 2019*, prepare and lay before Dáil Éireann a report on the appointment of an independent regulator for the domestic waste management sector with the authority to licence waste firms, to set prices, and to enforce its decisions where necessary through fines or sanctions or both.”. 15

2. This Act may be cited as the Waste Management (Amendment) (Regulator) Act 2019.
