An Act to give security to local authorities, by way of creating a charge on the land concerned, in relation to the expenses incurred by the local authority in order to give effect to measures which the local authority considers to be necessary in order to prevent the land from becoming or continuing to be a derelict site, for that purpose to amend the Derelict Sites Act 1990, and to provide for related matters. 5

Be it enacted by the Oireachtas as follows: 10

Amendment of Derelict Sites Act 1990

1. (1) The Derelict Sites Act 1990 is amended in section 11 by the insertion of the following after subsection (5):

“(5A) Expenses referred to in subsection (5) incurred by a local authority in giving effect to the terms of a notice (or a notice as amended) served under this section shall become and shall remain until payment thereof by the person on whom the notice (or the notice as amended) was served, a charge on the land concerned.” 15

(2) The amendment effected by *subsection (1)* applies to expenses incurred by a local authority in giving effect to the terms of a notice (or a notice as amended) served under section 11 of the Derelict Sites Act 1990 after the passing of this Act. 20

Short title, collective citation and construction

2. (1) This Act may be cited as the Derelict Sites (Amendment) Act 2021.

(2) This Act and the Derelict Sites Act 1990 may be cited together as the Derelict Sites Acts 1990 and 2021 and shall be construed together as one Act. 25

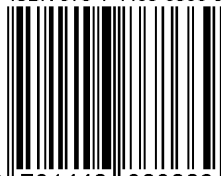
