An Act to amend the Civil Legal Aid Act 1995 to make provision for the exclusion of the value of free or partly free board as income when applying for civil legal aid.

Be it enacted by the Oireachtas as follows:

Interpretation

10

1. In this Act, “Principal Act” means the Civil Legal Aid Act 1995.

Amendment of section 37 of Principal Act

2. Section 37 of the Principal Act is amended in subsection (2) by the substitution of the following paragraph for paragraph (c):

“(c) make provision for the assessment by the Board or its staff of the means, income, disposable income, capital and disposable capital of applicants, the contributions payable by applicants, the waiving of contributions and the acceptance of lower contributions from applicants; excluding the value of free or partly free board;”

Short title, collective citation and commencement

3. (1) This Act may be cited as the Civil Legal Aid (Exclusion of Value of Free or Partly Free Board) (Amendment) Act 2021.
 - (2) This Act and the Civil Legal Aid Act 1995 may be cited together as the Civil Legal Aid Acts 1995 to 2021 and shall be construed together as one Act.
 - (3) This Act shall come into operation on such day or days as may be fixed by order of the Minister.
