An Act to amend the Planning and Development Act 2000 to ensure that every appeal or referral is determined within a period of 12 weeks beginning on the date of receipt by the Board of the appeal or referral, or, such other period as the Minister may prescribe in accordance with section 126(4) and section 221(4), either generally or in respect of a particular class or classes of appeals or referrals. 5

Be it enacted by the Oireachtas as follows: 10

PART 1

PRELIMINARY AND GENERAL

Short title, collective citation, construction and commencement

1. (1) This Act may be cited as the Planning and Development (Amendment) Act 2021.
- (2) This Act and the Planning and Development Acts 2000 to 2020 may be cited together as the Planning and Development Acts 2000 to 2021 and shall be construed together as one. 15
- (3) This Act comes into operation on such day or days as the Minister may appoint by order or orders, either generally or with reference to any particular purpose or provision, and different days may be so appointed for different purposes and different provisions. 20

Interpretation

2. In this Act—

“Minister” means Minister for Housing, Local Government and Heritage;

“Principal Act” means the Planning and Development Act 2000. 25

Expenses

3. The expenses incurred by the Minister in the administration of this Act shall, to such extent as may be sanctioned by the Minister for Public Expenditure and Reform, be paid out of moneys provided by the Oireachtas.
