SECTION 1

- 1. In page 5, lines 10 and 11 deleted and the following substituted:
 - "(ii) the date that is specified in a resolution passed by each House of the Oireachtas under subsection (6).",".
- 2. In page 5, lines 14 to 21 deleted and the following substituted:
 - ""(6) Each House of the Oireachtas may, before the 9th day of November 2021, pass a resolution to continue in operation the amendments effected by Part 3 for such period, not exceeding 3 months, that ends on a date specified in the resolution."."

SECTION 2

- **3.** In page 5, lines 30 and 31 deleted and the following substituted:
 - "(b) the date that is specified in a resolution passed by each House of the Oireachtas under subsection (4).".
- **4.** In page 5, lines 32 to 37 deleted, and in page 6, lines 1 to 3 deleted and the following substituted:
 - "(4) Each House of the Oireachtas may, before the 9th day of November 2021, pass a resolution to continue in operation the amendments to, and other modifications of, the Mental Health Act 2001 effected by Part 5 for such period, not exceeding 3 months, that ends on a date specified in the resolution."
- 5. In page 6, line 5, "stands" deleted and "is" substituted.

SECTION 3

- **6.** In page 6, lines 17 and 18 deleted and the following substituted:
 - "(b) the date that is specified in a resolution passed by each House of the Oireachtas under subsection (4).".
- 7. In page 6, lines 19 to 25 deleted and the following substituted:
 - "(4) Each House of the Oireachtas may, before the 9th day of November

 - "(4) Each House of the Oireachtas may, before the 9th day of November 2021, pass a resolution to continue this Act in operation for such period, not exceeding 3 months, that ends on a date specified in the resolution."."
