An Act to amend the Institutional Burials Act 2022 to enable Director of Authorised Intervention to engage in cases where precise burial places cannot be identified but where inappropriate burials are likely to have taken place in an institutional setting, to provide for cases where persons who consider that they are related to persons thought to be buried on principal burial land indicate that an excavation of the land is their preference, and to provide for related matters.

Be it enacted by the Oireachtas as follows:

Definitions

1. In this Act—

"Minister" means the Minister for Children, Equality, Disability, Integration and Youth;

"Principal Act" means the Institutional Burials Act 2022.

Amendment of section 2 of Principal Act

2. Section 2 of the Principal Act is amended in the definition of "principal burial land" by the insertion of "there is reasonable evidence to suggest that" after "where".

Amendment of section 7 of Principal Act

3. (1) Section 7 of the Principal Act is amended—

- (a) in subsection 3, by the substitution of ", including in cases where the precise location of burials cannot be identified, where there is reasonable evidence to suggest that" for "where they are satisfied that",
- (b) in subsection 3(a), by the insertion of "are reasonably likely to" after "burials",
- (c) by the insertion of the following subsections after subsection (3):

- "(3A) For the purposes of this section, 'evidence' means evidence of manifestly inappropriate burials, and may include, but not be limited to—
 - (a) missing burial records, or the absence of or conflicting information

- concerning the location(s) where persons who died while resident at the institution were buried,
- (b) records which indicate the presence of manifestly inappropriate burial sites, or
- (c) records which indicate an unusually high death rate at the 5 institution.
- (3B) The Government may make an order under subsection (1) where persons who consider that they are related to persons thought to be buried on principal burial land indicate that the making of an order is their preference, and where the making of an order would not contravene subsection (4).",

(d) by the deletion of subsection (5).

Short title, collective citation, construction and commencement

- **4.** (1) This Act may be cited as the Institutional Burials (Amendment) Act 2022.
 - (2) The Institutional Burials Act 2022 and this Act may be cited together as the Institutional Burials Acts 2022 and shall be construed together as one.
 - (3) This Act shall come into operation on such day or days as the Minister may by order or orders appoint either generally or with reference to any particular purpose or provision and different days may be so appointed for different purposes or different provisions.
