# **Bill**

*entitled*

An Act to amend the Constitution.

5

WHEREAS by virtue of Article 46 of the Constitution any provision of the Constitution may be amended in the manner provided by that Article:

AND WHEREAS it is proposed—

(A) to amend Article 12 of the Constitution; and

(B) in consequence of the foregoing, to amend otherwise the Constitution for the purpose of giving effect to the amendment of Article 12: 10

**Be it therefore enacted by the Oireachtas as follows:**

**Amendment of Article 12 of the Constitution**

1. Article 12 of the Constitution is hereby amended as follows:

- (a) the subsection, the text of which is set out in *Part 1 of Schedule 1*, shall be substituted for subsection 2° of section 2 of the Irish text; 15
- (b) the subsection, the text of which is set out in *Part 2 of Schedule 1*, shall be substituted for subsection 2° of section 2 of the English text.

**Insertion of Article 12A relating to legislation pursuant to amendment of Article 12**

2. The Constitution is hereby amended as follows: 20

- (a) the Article, the text of which is set out in *Part 1 of Schedule 2*, shall be inserted after Article 12 of the Irish text;
- (b) the Article, the text of which is set out in *Part 2 of Schedule 2*, shall be inserted after Article 12 of the English text.

3. (1) The amendment of the Constitution effected by this Act shall be called the Forty-first Amendment of the Constitution.
- (2) This Act may be cited as the Forty-first Amendment of the Constitution (Voting Rights in Presidential Elections) Act 2025.
