An Act to provide for the renaming of Dublin Airport as Seán Lemass Dublin International Airport and to provide for related matters. 5

Be it enacted by the Oireachtas as follows:

Interpretation

1. In this Act—

“DAA” means Dublin Airport Authority, being the airport authority for Dublin Airport; 10

“Dublin Airport” means the airport situated at Collinstown, County Dublin, operated by Dublin Airport Authority plc under the State Airports Act 2004;

“Minister” means the Minister for Transport.

Renaming of Dublin Airport

2. (1) On and from the commencement of this section, Dublin Airport shall be known as Seán Lemass Dublin International Airport. 15

(2) All references in any enactment, statutory instrument, legal document, map, sign, or public record to “Dublin Airport” shall, unless the context otherwise requires, be construed as references to Seán Lemass Dublin International Airport.

Direction to DAA 20

3. (1) The Minister may, for the purpose of giving effect to *section 2*, issue such directions to DAA as are necessary or expedient, including directions relating to—

(a) signage and branding,

(b) public communications and announcements,

(c) updates to official documentation and digital platforms. 25

(2) DAA shall comply with any direction issued under *subsection (1)*.

Short title and commencement

4. (1) This Act may be cited as the Seán Lemass Dublin International Airport Act 2025.

- (2) This Act shall come into operation on such day or days as the Minister for Transport may by order appoint, either generally or with reference to any particular purpose or provision, and different days may be so appointed for different purposes or provisions.
